MIGRANT INCIDENT IN THE DOVER STRAIT IN THE NORTHERN PART IN THE VICINITY OF THE SANDETTIE WEST BUOY. RNLI RAMSGATE WERE PAGED AS UKBF ASSETS WERE RESTRICTED DUE TO THEIR WORKING HOURS AND DOVER MRCC ONLY HAD UKBF VALIANT AVAILABLE AT THE TIME, RAMSGATE RNLI WERE THE CLOSEST AVAILABLE ASSET AT THE TIME. INITIAL CALL FROM THE RESPONDING TO THE PAGE REFUSED THE TASKING STATING "THAT IF UKBF WONT ATTEND THEN WE WONT GO AFLOAT EITHER." AFTER THIS INITIAL CALL A CONVERSATION WAS HELD WITH THE AT THE TIME IN SOLENT WITH DOVER MRCC REGARDING THIS, THE SUGGESTION FROM THE WAS TO SPEAK TO THE AGAIN AND INFORM HIM THE REASON FOR THE LACK OF UKBF ASSETS. A FURTHER PAGE WENT IN TO SPEAK TO THE OF WHICH HE WAS INFORMED THAT THE REASON UKBF ARE NOT OUT IS DUE TO THEIR RESTRICTED WORKING HOURS AND NO ASSET AVAILABLE UNTIL 6AM. RESPONDED AS SAYING " ITS UKBF NOT DOING THEIR JOB. WE ARE VOLUNTEERS. ALL THEIR CREW IS PAID TO BE OUT ITS GETTING RIDICULOUS". HE WENT ON TO SAY "IF THERES AN EMERGENCY AND YOUVE GOT PEOPLE IN THE WATER WE WILL GO AFLOAT BUT AT THE MOMENT I KNOW BY THE SOUND OF YOUR VOICE THAT THIS ISNT AN EMERGENCY" AND HE STATED THAT AT THIS TIME WE ARE STANDING DOWN.
