**2.0. Examination Summary**

2.1. On **16/10/2024**, the offices of SYTECH received an Egress link which contained data relating to an Apple mobile device. This data was downloaded on **16/10/2024** onto an encrypted SSD to conduct the examination. Please note, the extractions for the Apple mobile device were provided by The Cranston Inquiry, therefore I am unable to comment on as to whether the extraction methods were accredited or not.

SYTECH then proceeded to forensically examine the mobile telecommunications equipment as described in the summary of instruction.

Details of the examinations are as follows:

2.2. The mobile device was examined whereby the raw data was carved automatically and manually analysed using “*Cellebrite Physical Analyser/ Cellebrite Reader*” and any items of interest were extracted.

2.2.1. The full data results are recorded in the output report **Device Examination Report** provided on **WJKD-01-291024**.

2.3. The associated SIM Card was analysed using the digital forensic tool “*Cellebrite Physical Analyzer/ Cellebrite Reader*” to search for any live user-based data.

2.3.1. The full data results are recorded in the output report **Device Examination Report** provided on **WJKD-01-291024**.

2.4. All of the above processes conducted at SYTECH were performed following SYTECH's procedures and in line with the ACPO guidelines for Digital Forensics.

2.5. On completion of the examination, the generated materials were placed within a password protected ZIP folder, ready to be returned to the instructing party via Egress.

All of the media files stored within both file locations are a result of application cache.

Application cache is data that is temporarily stored onto the device to increase file accessibility speed, thus enhancing the user's experience. Cached media files are a result of automatic system process, therefore the device user would have not knowingly or intentionally created these media files onto the device, however cached media files do provide an indication as to what was viewable to the device user at the time of these cached media files being created.

The "*Phone*" application allows the device user to make and manage phone calls.

The "*Safari*" application is an Apple web browser that can allow a device user to access and search the internet.
