## CRANSTON INQUIRY

## **PRE-INCIDENT CHRONOLOGY**

This pre-incident chronology sets out background context to the events of 23-24 November 2021. It does not purport to be and is not exhaustive or conclusive or final. Entries in the chronology are drawn from the cited source material; inclusion in this chronology does not denote the Inquiry's acceptance of the accuracy of these entries.
